- 1- For the whole period, the electrical energy is asked under the following profile: Continuous delivery from Monday to Sunday, **00:00 to 24:00 of CET** (24 hour) and **06:00 to 24:00 of CET** (18 hour), (CET Albanian Local Time).
- 2- The Bid Evaluation Criteria is: The lowest unit/price up to the completion of the required quantities of electrical energy, up to 17,982 MWh for Option 1, or up to 29,970 MWh for Option 2 or up to 47,952 MWh for Option 3. The contract shall be awarded to the company who will offer the lowest unit/price.
- 3- The companies are incouraged to offer total required quantities for the whole period, but offers that submitt lower quantites than the total required quantity, will also be accepted. Companies have to offer supply of electrical energy for the whole required period without interruptions and without changed power.
- 4- KESH sh.a. has the absolute right to accept fully or partially the quantities of electrical energy submitted by the companies.
- 5- KESH j.s.c will negotiate in a second phase with the 5 companies/bidders that in the first phase will submit the lowest unit/prices, according on point 4, of article 13 of the Purchase Procedure by KESH jsc, approved by Albanian Regulatory Entity according to Decision no.30, date 23.03.2011 and published at official website: www.ere.gov.al.
- 6- In the unit/price is included the value of fiscal obligations, but is not included the value of VAT. Only for comparison and evaluation reasons, the classification of the offers will be based on the lowest unit/price that does not include the value of VAT (with the delivery condition DAP Albanian Border).
- 7- The contract with the foreign companies will be signed only based on the final offer's unit/prices and value of their offer, in which the value of VAT and other fiscal obligations, will not be included. The contract with the local companies will be signed with the total value of the final offer (which includes VAT value + the values of all fiscal obligations recognized by the Albanian Legislation).
- 8- The Buyer/KESH jsc will not issue bank guarantees, make prepayment or other financial conditions requested. Abovementioned financial conditions from companies will not be considered and will bring disqualification of participant/s.
- 9- KESH j.s.c will make the payment within 30 until 60 days after the delivery of electricity.
- 10- KESH j.s.c, requests to all interested companies that will participate in this procedure to submit only one price for the whole period, according to the option, which may be for the all required quantity or for partial quantity.
- 11- Other criteria of participation to the purchasing procedure is the submission of legal-financial documentation stipulated in the article 10 of KESH j.s.c Purchase Procedures,

- approved by Albanian Regulatory Entity and published at official website: www.ere.gov.al (except the companies that have submitted this documentation at KESH j.s.c).
- 12- Competitive Authority reserves the right to cancel the purchasing procedure before was signed the contract, according in the article 18 of the Purchase Procedures by KESH jsc, approved by Albanian Regulatory Entity according to Decision no.30, date 23.03.2011 and published at official website: www.ere.gov.al.
- 13- All offers must have a validity period until 23 July, 2015, hour 14.00, Albanian local time. Offers without validity period or with validity period shorter than 23 July, 2015, hour 14.00, Albanian local time, will be automatically disqualified.

- 16- In case that you will prefer to send your offer by mail, the envelope must be sent to the Protocol Office of KESH jsc, not later than 22.07.2015 at 16.00 hrs. Envelopes arriving later than this date and hour will not be accepted and evaluated.

- 17- According to point 3, of article 13 of the Purchase Procedure by KESH jsc, all the interested companies are invited on KESH jsc, date 22.07.2015, at 16.00 hrs, to be part of opening and reading the offer from purchase commission.
