5. In the unit/price is included the value of fiscal obligations of the buyer from the delivery point, but is not included the value of VAT. Only for comparison and evaluation reasons, the classification of the offers will be based on the highest unit/price that does not include the value of VAT.

6. The traders will make the payment to KESH jsc within 20 days after the last day of delivery.
